



## STOCK MARKET REPORT FOR MARCH 31ST, 2017

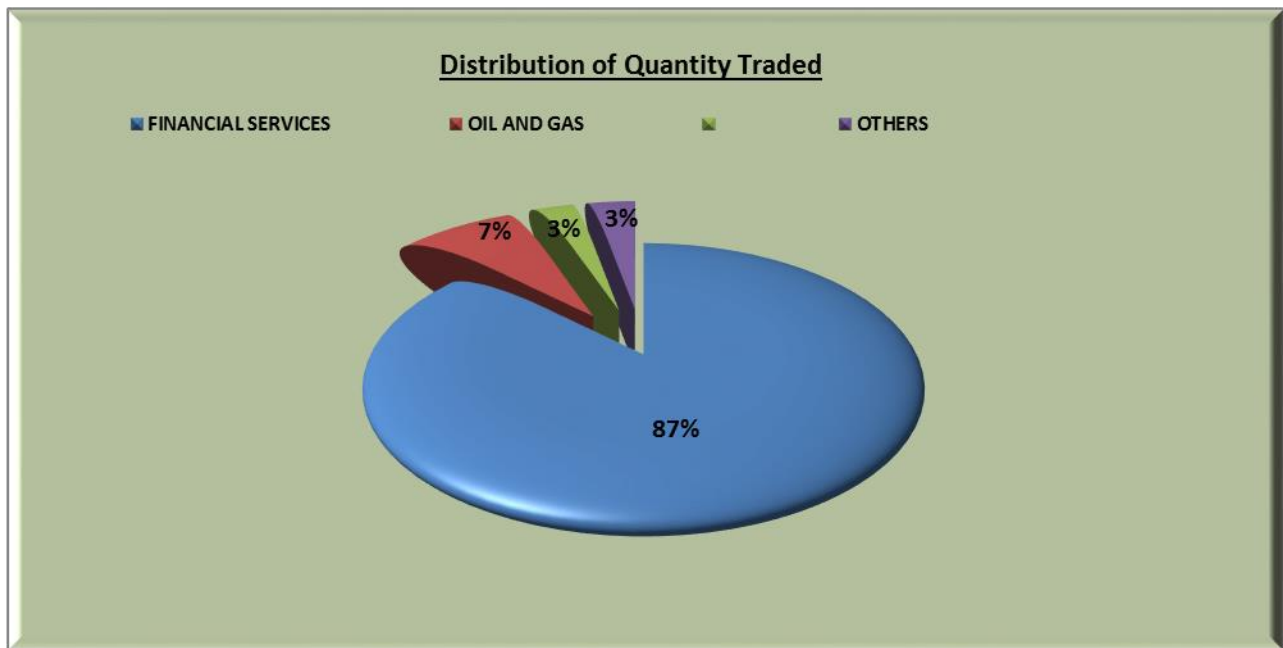
A total turnover of 3.195 billion shares worth N104.217 billion in 14,674 deals were traded this week by investors on the floor of the Exchange in contrast to a total of 1.309 billion shares valued at N10.323 billion that exchanged hands last week in 13,042 deals.

The Financial Services Industry (measured by volume) led the activity chart with 2.784 billion shares valued at N7.932 billion traded in 9,129 deals; thus contributing 87.12% and 7.61% to the total equity turnover volume and value respectively. The Oil and Gas Industry followed with 233.982 million shares worth N92.545 billion in 1,410 deals. The third place was occupied by Consumer Goods Industry with a turnover of 80.623 million shares worth N1.957 billion in 2,138 deals.

Trading in the Top Three Equities namely – Niger Insurance Co. Plc, Standard Trust Assurance Plc and Continental Reinsurance Plc (measured by volume) accounted for 1.523 billion shares worth N1.145 billion in 76 deals, contributing 47.68% and 1.10% to the total equity turnover volume and value respectively.
